Country team inputs per session

In addition to the Reporting Templates with DDS -and CPS where available-, there are two country team inputs that require preparatory work ahead of the meeting. These are:

1. Country sessions (From Day 1 to Day 3 depending on country)

Country sessions are dedicated to individual country teams. They should cater for exchanges with the attending participants that are most useful to the country teams in the process of finalising the work under this project with the best possible outcomes. Therefore, we strongly encourage country teams to think ahead of the session "what would we like to get out of this session?" and liaise with us as much as necessary to prepare the specifics of the design of the session.

Two basic inputs are requested for each of the country sessions:

- 1. <u>Country teams</u> are asked to prepare a couple of slides to answer (PPT template is provided):
 - a. What is really new in your work that would like to share and publish? What makes it most interesting and innovative?
 - b. What is blocking further progress with your country work? What do you need support with?
- 2. In addition, external experts have been kindly asked to review the Reporting Templates for the submitted DDS and prepare a 5 to 10-minute feedback response as input for the session discussions.

2. Policy and stakeholder engagement session (Day 2)

This session will serve the purpose of sharing information about engagement strategies envisaged by the different country teams, challenge each other about strategies and their analytical content and identify the additional layer of analysis (beyond the pathways in the reporting template) that is needed to implement the engagement strategies. The discussion on processes, tools and methods at projectlevel that may be required to facilitate the domestic engagement strategies will be followed-up in the "Next Steps" session of Day 3.

To facilitate the peer-to-peer sharing of engagement strategies within the time constraints of the session, we kindly ask each country teams to respond to the following questions, according to the PPT template that is provided:

- What are the key changes (transformations required under your DDP pathway) that you are specifically targeting as objective of your policy engagement strategy?
- Who are all the agents (people, institutions) that can make these key changes happen?
- How do you plan to engage with them concretely?
- What (additional) analysis would you require to have a compelling and concrete argument to these agents in relation to the key changes?

Depending on your engagement strategy, you might need to repeat these questions for a number of sub strategies, for instance, for each of the sector-level engagement if you adopt a sectoral view that requires different approaches across sectors.

Please note that peer-review comments and other structured inputs by IDDRI will be prepared on the basis of the submitted scenarios, always bearing mind the *work-in-progress* nature of the scenario work that has been delivered. Pre-recorded presentations of the results in PPT format may accompany the Reporting Templates to support its interpretation. These prerecordings are optional.

No other inputs/PPTs are requested for any other session of the Project Meeting.
