"Achieving carbon neutrality: how to ensure a just transition?"

The lead up to COP30 in Belem offers a unique opportunity to reflect on the important milestone of the implementation of the Paris Agreement in the year of its tenth anniversary. Securing a just transition will indeed remain a key part of the implementation of the objectives of the Paris Agreement and national-level perspectives will be key to better understand the concrete challenges faced by countries in the implementation of GHG emission reduction goals aligned with a sustainable and just transition.

At the forefront of these challenges and playing a leading role in 2024-2025 through the BRICS+ presidency and the COP30 presidency, Brazil currently plays and will continue to play a major role in international relations and the international climate agenda.

This event aims to facilitate several engagement activities in Brazil in line with Paris Agreement implementation challenges, with the support of the Federal University of Rio de Janeiro, involving its Centro Clima, as well as IDDRI – Institute of Sustainable Development and International Relations (Paris), and supporting French governmental entities (Institut Français and the French Consulate in Rio de Janeiro). It is labeled as part of the 2025 France-Brazil Crossed Season.

It will build on insights shared on 6 October 2025, during the launch of the 2025 Deep Decarbonization Pathways (DDP) Report at the Brazilian Embassy in Paris. That high-level event, scheduled for early October, will mark ten years since the adoption of the Paris Agreement. It will bring together experts and decision-makers to reflect on progress, challenges, and priorities ahead of COP30. Discussions from the Paris event will provide valuable input for the follow-up exchanges in Brazil.

The research project "2050 is Now" jointly implemented by IDDRI, as coordinator of the project, the World Resources Institute – WRI, Centro Clima/COPPE/UFRJ and other international partners, and supported by IKI – International Climate Initiative of the German Government, promotes international dialogues between climate experts to identify key opportunities and challenges for international cooperation towards the goals of the Paris Agreement, providing support to countries on the development of their national long-term low emission development strategies (LTS) and government planning on decarbonization.

The IKI-LTS project aims at a characterization of development scenarios towards 2050-70 that are compatible with achieving carbon neutrality and other national environmental and socioeconomic objectives.























Scientific output from this research project will deliver specific analyses on the critical aspects for ensuring a just transition in Brazil and will put them up for debate at the event.

In addition, the event offers the opportunity to introduce the 2025 Report "A decade of climate action: stocktake and the road ahead" from the Deep Decarbonization Pathways initiative (DDP), an international network of climate scientists working in national-level transitions, providing decision-makers with robust pathways to net-zero, while remaining on track with national economic development objectives. The report provides a fresh batch of new country-level perspectives on national transitions from a wide array of developing and developed countries. This collective output, which includes analysis from the Brazilian context and from other major emerging economies, offers valuable country-level lessons learnt from the evolution of national transitions since the inception of the Paris Agreement and sheds light on the direction new collective efforts should take going forward.
